2. Not having been sentenced to imprisonment by Thai court's judgment or lawful order, or foreign court's judgment, except for the case of petty offence or an offence committed to negligence
3. Not being a person who has arrest warrant issued by Thai government or foreign government, nor a person whose name is listed in Thai or foreign government's watch list.
4. Not having been exiled by Thai government or foreign government or deported by the official.
5. Not being a person considered harmful to the society or likely to disturb the peace or public safety or security of the Kingdom of Thailand.
6. Not being a person entering into the Kingdom of Thailand and engaged in business against public order or good moral.
7. Being a person permitted to reside in or enter into the Kingdom of Thailand in accordance with the Immigration Act B.E. 2522 or other immigration related laws.
8. Being a person travelling to or departing the Kingdom of Thailand via the channels, checkpoints, stations, or areas designated in the Immigration Act B.E. 2522 or other immigration related laws.
9. Being a person travelling to or departing the Kingdom of Thailand and having submitted all particulars in accordance with the forms, methods, and conditions required and having passed immigration checking processes by immigration officer at the underlying checkpoint.
10. Not being a person involved, directly or indirectly, in bankruptcy or insolvency liquidation.
11. Not being a person involved, directly or indirectly, in money laundry or financial crime.
12. I am aware of my duty to conduct a 90-day report when I stay 90 days consecutively in Thailand.
13. I am aware of my duty to present myself to the Immigration Bureau when I stay 365 days consecutively in Thailand irrelevant to the 90-day reports which I accomplish prior to the 365 days consecutive stay.
14. I am aware of the application condition of which I must not have more than one overstays record in Thailand in the past three years.
15. I am aware of my duty to keep my residence record in Thailand so called TM30.

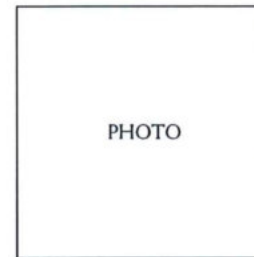

## TERMS AND CONDITIONS OF UPGRADED ELITE ULTIMATE PRIVILEGE MEMBERSHIP (the "Upgraded Elite Ultimate Privilege Membership Agreement")

By enrolling in this Upgraded Elite Ultimate Privilege Membership, the Upgraded Elite Ultimate Privilege Member agrees to be bound by the Upgraded Elite Ultimate Privilege Membership Agreement set out below. By applying for or purchasing the Upgraded Elite Ultimate Privilege Membership or acquiring the Privileges, the Upgraded Elite Ultimate Privilege Member represents that he/she has all qualifications as required in Clause 6 (Qualifications of the Applicant/Upgraded Elite Ultimate Privilege Member). The Upgraded Elite Ultimate Privilege Member agrees that the Company may from time to time amend or supplement the Upgraded Elite Ultimate Privilege Membership Agreement.

This Upgraded Elite Ultimate Privilege Membership Agreement is incorporated into and forms part of the Application for the Upgraded Elite Ultimate Privilege Membership.

### 1. Definition:

- a) **"Application"** means the application form for Upgraded Elite Ultimate Privilege Membership;
- b) **"Annual Fee"** means the annual fee to be paid by the Upgraded Elite Ultimate Privilege Member to the Company upon the lapse of every twelve (12) month period starting from the date of Company's approval of the Application throughout the validity period of the Upgraded Elite Ultimate Privilege Membership, in order to maintain the Upgraded Elite Ultimate Privilege Membership status, which is to be discussed more particularly in detail under Clause 5.2;
- c) **"Card"** means the membership card approved and issued to the Upgraded Elite Ultimate Privilege Member by the Company pursuant to the terms and conditions of this Upgraded Elite Ultimate Privilege Membership Agreement;
- d) **"Card Reissuing Fee"** means the fee to be paid by the Upgraded Elite Ultimate Privilege Member to the Company when the Upgraded Elite Ultimate Privilege Member requests for the issuance of the new card due to loss or damage to the Card, which is to be discussed more particularly in detail under Clause 5.4;
- e) **"Company"** means Thailand Privilege Card Company Limited;
- f) **"Exchange Rate"** means the exchange rate for conversion of foreign currency to Thai Baht announced by the Bank of Thailand, which will be notified by the Company or the Sales Agent (as the case maybe) to the applicant/the Upgraded Elite Ultimate Privilege Member upon a request by the Upgraded Elite Ultimate Privilege Member;
- g) **"Member Contact Centre"** means a contact centre of the Company or the Service Provider with which the Upgraded Elite Ultimate Privilege Member may make contact via a telephone or other communication channels as stipulated in the e-Privilege, or as the Upgraded Elite Ultimate Privilege Member shall be advised from time to time;
- h) **"Membership Transfer Fee"** means the fee to be paid by the applicant for the transfer of the Elite Ultimate Privilege Membership (from the Elite Easy Access Membership) to the Company pursuant to Clause 2.4, which is to be discussed more particularly in detail under Clause 5.3;
- i) **"Membership Upgrade Form"** means the upgraded membership form applied by the applicant/Upgraded Elite Ultimate Privilege Member, which forms part of and is integral to this Upgraded Elite Ultimate Privilege Membership Agreement;
- j) **"Penalty Charge"** means the charge to be paid by the Upgraded Elite Ultimate Privilege Member to the Company pursuant to the terms and conditions of this Upgraded Elite Ultimate Privilege Membership Agreement and the e-Privilege, which is to be discussed more particularly in detail under Clause 5.5;
- k) **"Prevailing Rate"** means the latest rate of the Upgraded Elite Ultimate Privilege Membership Fee announced by the Company in writing;
- l) **"E-Privilege"** means the e-Privilege and card holder manual which prescribe the terms and conditions of the Privileges and other details relevant to the Elite Ultimate Privilege Membership and the Elite Easy Access Membership, which shall be provided to the Upgraded Elite Ultimate Privilege Member by the Company once the Company has approved the Application and received the Upgraded Elite Ultimate Privilege Membership Fee and thereafter every subsequent year;
- m) **"Privileges"** means exclusive privileges as set out in the e-Privilege which are applicable to the Elite Ultimate Privilege Membership under the Elite Ultimate Privilege Membership Agreement and the Upgraded Elite Ultimate Privilege Membership under this Upgraded Elite Ultimate Privilege Membership Agreement, and which may be, from time to time, updated or amended by the Company;
- n) **"Sales Agent"** means an authorized representative of the Company;
- o) **"Service Provider"** means any person or any juristic entity, which may be developed from time to time, collaborating with the Company in providing the Privileges in relation to the Upgraded Elite Ultimate Privilege Membership as set out in the e-Privilege, or as the Upgraded Elite Ultimate Privilege Member shall be advised from time to time.
- p) **"Elite Easy Access Member"** means the applicant under the Upgraded Elite Ultimate Privilege Membership who prior to applying for the Upgraded Elite Ultimate Privilege Membership was granted Elite Easy Access Membership;
- q) **"Elite Easy Access Membership"** means the membership with the 5-year validity and under Privileges with regard specifically thereto set forth in the Elite Easy Access Membership Agreement, which the Upgraded Elite Ultimate Privilege Member (or, the then Elite Easy Access Member) was enjoying prior to applying for the Upgraded Elite Ultimate Privilege Membership;
- r) **"Elite Easy Access Membership Fee"** means the value of the Elite Easy Access Membership of THB 500,000 (five hundred thousand Baht) Inclusive of VAT, which the Elite Easy Access Member paid to the Company upon the Company's approval of its Elite Easy Access Membership prior to applying for the Upgraded Elite Ultimate Privilege Membership;
- s) **"Elite Easy Access Membership Agreement"** means the Elite Easy Access Membership agreement to and under which the Elite Easy Access Membership specifically prescribed is applied by, approved to, and vested in the Upgraded Elite Ultimate Privilege Member (or, the then Elite Easy Access Member) prior to the upgrade of Privileges under this Upgraded Elite Ultimate Privilege Membership Agreement;
- t) **"Elite Ultimate Privilege Membership"** means the Elite Ultimate Privilege Membership under the Privileges specifically prescribed thereto, to which the Upgraded Elite Ultimate Privilege Member wishes to upgrade under this Upgraded Elite Ultimate Privilege Membership Agreement, or to which an applicant who has qualifications under Clause 6 and wishes to apply (as the case may be);
- u) **"Transferred Elite Ultimate Privilege Membership"** means the Elite Ultimate Privilege Membership under which the Upgraded Elite Ultimate Privilege Member enjoys after approval of the Application, and which the Upgraded Elite Ultimate Privilege Member wishes to transfer to any person whose qualifications meet the requirement under Clause 6 and whose application for such transfer has been approved by the Company.
- v) **"Upgraded Elite Ultimate Privilege Member"** means the applicant under the Application whose Upgraded Elite Ultimate Privilege Membership has been approved by the Company
- w) **"Upgraded Elite Ultimate Privilege Membership"** means the Elite Ultimate Privilege Membership approved to the applicant/Upgraded Elite Ultimate Privilege Member by the Company for the enjoyment of Privileges specifically prescribed thereto under this Upgrade Elite Ultimate Privilege Membership Agreement; and
- x) **"Upgraded Elite Ultimate Privilege Membership Fee"** means the membership fee which the applicant/Upgraded Elite Ultimate Privilege Member shall pay to the Company for the escalation of privilege class from the Elite Easy Access Membership to privilege class of the Upgraded Elite Ultimate Privilege Membership, which is to be discussed more particularly in detail under Clause 5.1.



## 2. Terms of Upgraded Elite Ultimate Privilege Membership

### 2.1 Conditions Precedent

The Company's approval, as well as receipt of the Upgraded Elite Ultimate Membership Fee, shall be conditions precedent for this Upgraded Elite Ultimate Privilege Membership Agreement.

### 2.2 Personal Information

The Upgraded Elite Ultimate Privilege Member agrees that the Company may check or reveal any personal information or any information provided in the Application or provided otherwise to the Company. This consent shall survive the termination or expiration of this Upgraded Elite Ultimate Privilege Membership Agreement. The checking and the revealing shall be limited for the purpose of the Upgraded Elite Ultimate Privilege Membership, or related services thereto, or other purposes as permitted by the law of the relevant countries.

### 2.3 Validity of Upgraded Elite Ultimate Privilege Membership

Subject to each of the Privileges' specific enjoyment period stated in Clause 4, the term of the Upgraded Elite Ultimate Privilege Membership shall be valid for the period of twenty (20) years, which is the validity period of Privileges under the Elite Ultimate Privilege Membership, less the number of privilege years under the 5-year validity of the Elite Easy Access Membership which has been used up by the applicant/Upgraded Elite Ultimate Privilege Member as of the date of the Company's approval of the Application, which is specifically stated in the Application; provided that the Upgraded Elite Ultimate Privilege Member shall consecutively pay the Annual Fee or arrange for the same to be consecutively paid per annum, and pay the Penalty Charge (if any) and other fees (if any) or arrange for the same (if any) to be effectively and fully paid to the Company within the due date specified in the Company's or the Service Provider's invoice or any other document to the same effect.

The unpaid Annual Fee and/or Penalty Charge (if any) and/or other fees (if any) will be treated as delinquent amount. If the Company does not receive full payment of such amount within the payment due date as specified in the Company's or the Service Provider's invoice or any other document to the same effect, then the Company shall be entitled to suspend all Privileges for the Upgraded Elite Ultimate Privilege Member at the Company's discretion until payment of such delinquent amount is made in full plus interest for late payment at the accrual rate of seven point five percent (7.5%) per annum.

### 2.4 Membership Transfer

Subject to prior approval by the Company and payment of the Membership Transfer Fee as stated in Clause 5, the Upgraded Elite Ultimate Privilege Membership and the Privileges can be transferred to any third party who has qualifications as stated in Clause 6 *mutatis mutandis*, provided such transfer shall be allowed to be made only one (1) time and after the transfer, the term of the Transferred Elite Ultimate Privilege Membership is subject to the remaining period of the Upgraded Elite Ultimate Privilege Membership under this Upgraded Elite Ultimate Privilege Membership Agreement. For the avoidance of doubt, the term of Transferred Elite Ultimate Privilege Membership will expire upon the lapse of the validity period of the Upgraded Elite Ultimate Privilege Membership as stated in Clause 2.3 above.

### 2.5 Termination :

#### (1) Automatic Termination

The Upgraded Elite Ultimate Privilege Membership shall be automatically terminated once the Upgraded Elite Ultimate Privilege Member dies or fails to maintain any of the qualifications set out in Clause 6, or it is apparent that the information provided by the applicant/Upgraded Elite Ultimate Privilege Member to the Company regarding the qualifications under Clause 6 is untrue.

#### (2) Termination due to Inappropriate Conducts

The Company may terminate the Upgraded Elite Ultimate Privilege Membership by giving an advance written notice to the Upgraded Elite Ultimate Privilege Member upon the occurrence of any of the following events:

- (a) The Upgraded Elite Ultimate Privilege Member has conducted any act which is considered to be illegal or contrary to public order or good morals and has negative impact on the images or business operations of the Company;
- (b) The Upgraded Elite Ultimate Privilege Member has fraudulently used his/her Privileges; or
- (c) The Upgraded Elite Ultimate Privilege Member has not complied with terms and conditions of this Upgraded Elite Ultimate Privilege Membership Agreement or the e-Privilege.

#### (3) Termination due to Government Policies

In case there is any order, rule, regulation or law announced by any related government authority which has an impact on the business operation of the Company to the effect that the Company is unable to continue its business or perform its operation as usual, the Company shall be entitled to terminate the Upgraded Elite Ultimate Privilege Membership by giving an advance written notice to the Upgraded Elite Ultimate Privilege Member.

#### (4) Rights and Duties after Termination

  - (i) The Penalty Charge and/or outstanding fees; and
  - (ii) The costs of Privileges which have been used by the Upgraded Elite Ultimate Privilege Member during the validity of Upgraded Elite Ultimate Privilege Membership.



### 3. Service Access

- 3.1 The Card and the Upgraded Elite Ultimate Privilege Member's identification number are the keys to access the Privileges. - 3.2 The Card or any proof of identity or any other evidence (as agreed by the Company and the Service Provider) must be shown to the Service Provider before obtaining the Privileges.
- 3.3 Signature as similarly appeared on the passport or on the Application shall be required from the Upgraded Elite Ultimate Privilege Member for the use of any services.

### 4. Privilege Usage and Benefits

  - (8) Special Discounts at hotels, dining establishments, shopping malls and duty free shops; and
  - (9) Member Contact Centre – English, Korean, Mandarin and Japanese.The Company reserves the rights to change the above limitation of usage from time to time at its sole discretion.

- 4.2 The Company reserves the rights to modify, cancel and/or prescribe further limitation on any of the Privileges without prior notice. The use of the Privileges shall be subject to the specific terms and conditions as stated in the e-Privilege. The e-Privilege, as may be amended or supplemented, is considered an integral part of this Upgraded Elite Ultimate Privilege Membership Agreement. In case any of the Privileges has been used by the Upgraded Elite Ultimate Privilege Member up to the limited number as prescribed in Clause 4.1 or pursuant to this Clause 4.2 at any time in the future, the Upgraded Elite Ultimate Privilege Member agrees to pay the Company an additional charge for additional usages of the relevant Privileges in accordance with the rate which shall be notified to the Upgraded Elite Ultimate Privilege Member from time to time.

- 4.3 The change of the Privileges or the Service Provider will be notified from time to time to the Upgraded Elite Ultimate Privilege Member.

- 4.4 Any of the Privileges may be cancelled if it is prohibited by the laws of Thailand.

- 4.5 The scope of Privileges shall be in accordance with the specific terms and conditions as stated in the e-Privilege.

- 4.6 Subject to the membership transfer pursuant to Clause 2.4, the Privileges are considered to be personal rights of and inured only to the Upgraded Elite Ultimate Privilege Member, and in no case shall the Privileges be inheritable, or devisable.

#### 4.7 Liabilities & Limitations :

- (1) The Company shall not be liable to the Upgraded Elite Ultimate Privilege Member or a third party for any products or services provided by Service Provider to the Upgraded Elite Ultimate Privilege Member for any delay and/or defect in performance of the same by any reason whatsoever. Such limitation shall cover any loss or injury or any direct, indirect, incidental, consequential, punitive, or similar damages arising out of the use or the inability to use the Privileges. This limitation applies irrespective of whether the alleged liability is based on contract, tort, negligence, strict liability, or any other basis, even if the Company has been advised of the possibility of such damage. The Upgraded Elite Ultimate Privilege Member hereby waives any and all claims against the Company arising out of the use or the inability to use the Privileges.
- (2) All expressed or implied warranties, representations, statements, terms and conditions relating to the Privileges or this Upgraded Elite Ultimate Privilege Membership Agreement, not contained in this Upgraded Elite Ultimate Privilege Membership Agreement and/or the e-Privilege, are excluded from this Upgraded Elite Ultimate Privilege Membership Agreement to the extent permitted by law. The aggregate liability of the Company under or relating to this Upgraded Elite Ultimate Privilege Membership Agreement whether in contract, tort (including without limitation to negligence) is limited to an amount equal to the Upgraded Elite Ultimate Privilege Membership Fee paid by the Upgraded Elite Ultimate Privilege Member to the Company under this Upgraded Elite Ultimate Privilege Membership Agreement.
- (3) The Upgraded Elite Ultimate Privilege Member agrees that the Company shall have the rights at all time to assign wholly or in part any or all of its rights, duties, and obligations to any of its affiliates or any other person, provided that the Upgraded Elite Ultimate Privilege Member is notified in writing prior to any such assignment.

### 5. Fee(s) and Conditions

#### 5.1 Upgraded Elite Ultimate Privilege Membership Fee

The Upgraded Elite Ultimate Privilege Membership Fee is at THB 1,500,000 (one million and five hundred thousand Baht) exclusive of value added tax (calculated at the rate applicable at the time of application) or an equivalent amount in USD pursuant to the Exchange Rate which will be notified by the Company or the Sales Agent (as the case may be) to the applicant/Upgraded Elite Ultimate Privilege Member. ### 6. Qualifications of Applicant/Upgraded Elite Ultimate Privilege Member

The applicant/Upgraded Elite Ultimate Privilege Member must have and maintain to have following qualifications:

- 6.1 Neither having been sentenced by a judgment to imprisonment in any countries except for in case of a petty offence or an offence committed to negligence, nor being a fugitive from justice, i.e. an accused of criminal activities running away from trial, or a convicted felon escaping from penitentiary;
- 6.2 Neither having been adjudicated bankrupt, nor insolvent;
- 6.3 Neither having been declared as a person of unsound mind, incompetence, nor quasi-incompetence;
- 6.4 Being allowed to stay in Thailand in accordance with the immigration laws or any other related laws of Thailand;
- 6.5 Holding a foreign passport; and
- 6.6 Being sui juris under Thai law and having attained the age of or over twenty (20) years old.

### 7. Interpretation

In the event that interpretation of the terms and/or conditions of this Upgraded Elite Ultimate Privilege Membership Agreement or any part of this Upgraded Elite Ultimate Privilege Membership Agreement or document that is deemed a part of this Upgraded Elite Ultimate Privilege Membership Agreement or any of the terms and conditions stipulated in the e-Privilege is needed, the Upgraded Elite Ultimate Privilege Member hereby agrees that the Company's interpretation shall be conclusive. If there is any inconsistency between the terms and/or conditions of this Upgraded Elite Ultimate Privilege Membership Agreement and the terms and/or conditions of the e-Privilege, the terms and conditions of this Upgraded Elite Ultimate Privilege Membership Agreement shall prevail.

### 8. Governing Law

This Upgraded Elite Ultimate Privilege Membership Agreement shall be governed by and construed in accordance with the laws of Thailand.

### 9. Notice

- 9.1 Any notice or other communication in connection with this Upgraded Elite Ultimate Privilege Membership Agreement shall be made in writing in English language (a "Notice") and shall be sufficiently given or served if delivered or sent:
  - (1) In the case of the Upgraded Elite Ultimate Privilege Member to the mailing address as stated in the Application or any other address as shall be notified by the Upgraded Elite Ultimate Privilege Member to the Company from time to time.
  - (2) In the case of the Company to below address, or any other addresses (including that of the Service Provider) as stated in the e-Privilege, or as shall be notified by the Company to the Upgraded Elite Ultimate Privilege Member from time to time.

The Upgraded Elite Ultimate Privilege Member agrees and acknowledges that at any time based on the Company's discretion, the Company may waive its right to demand any compliance with the terms and conditions of this Upgraded Elite Ultimate Privilege Membership Agreement or the e-Privilege from the Upgraded Elite Ultimate Privilege Member. Such waiver shall not affect any right of the Company to enforce the terms and conditions of this Upgraded Elite Ultimate Privilege Membership Agreement or the e-Privilege at any time in the future.
